3. The vendor should have minimum three years of business experience.
4. The annual turnover should be not less than Rs. 1 Crore.
5. Self attested copy of past three years Balance sheet & Income Tax returns should be submitted.
6. Provident Fund No., Service Tax Number & PAN Card No. should be available.
7. The agency should not be black listed by any organization.
8. List of self attested Documents to be attached: (a) Copies of Three years balance sheet; (b) Copy of Company/Firm registration; (c) latest Copy of PF Challan (d) Copy of Pan Card.
9. Please indicate minimum 5 to 10 recognized client with whom you have contract at present.
