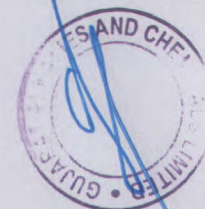

Resignation from the services of the GACL effective 18th November, 2023


