We are pleased to inform you that today, the Company has inaugurated the Hydrogen supply pipeline to NOCIL at Dahej. The inauguration was graced by the senior leadership team of Gujarat Alkalies and Chemicals Limited (GACL) along with Managing Director of NOCIL.

Through this newly commissioned pipeline, the Company will be supplying approximately 20,000 Nm³/day of Hydrogen to NOCIL. This will contribute annual revenue of about Rs. 9 Crores, marking another milestone in the Company's growth journey.

GACL and NOCIL has executed an agreement for supply of Hydrogen Gas for 5 years and it will be renewed further as per the mutual agreement between GACL and NOCIL.
